

BY-LAW NUMBER 815

BEING A BY-LAW of the Corporation of the City of North Bay for closing certain streets within the said Corporation.

WHEREAS the Municipal Corporation of the City of North Bay deems it advisable to close certain streets within the City of North Bay and to sell and convey same.

THEREFORE the Municipal Corporation of the City of North Bay enacts as follows:-

That the following streets in the City of North Bay be and the same are hereby closed and stopped up.

<u>STREET</u>	<u>FROM</u>	<u>TO</u>
Shaw Street	Trout Lake Road	City Limits.
High St. formerly Stevens Street	Shaw Street	Lot 19, Con. C.
High Street	Olive Street	Easterly termination.
Rose Avenue	Olive Street	Lot 19, Con. C.
Lorne Avenue	Olive Street	Lot 19, Con. C.

1. The portions of said streets to be closed and stopped hereunto being more particularly described in Schedule "A" hereunto annexed.
2. That the said Council shall bear in person or by his counsel, solicitor or agent, any person who claims that his lands will be prejudicially affected by this By-law and who applies to be heard.
3. That forthwith upon this By-law taking effect the Corporation of the City of North Bay shall convey to the Board of Governors of the Home for the Aged, for the consideration of \$1.00 all the portions of said streets closed and stopped up under the provisions hereof.
4. That this By-law shall take effect after notice of same has been published once a week for four consecutive weeks after final passing thereof.

SCHEDULE "A".

THIS IS SCHEDULE "A" referred to in By-law Number 815 of the City of North Bay.

PARCEL A - That portion of Shaw Street beginning at the northerly boundary of Trout Lake Road and ending at the northerly limit of the City of North Bay.

PARCEL B /That portion of High Street formerly Stevens St. beginning at the intersection between Shaw Street and High Street formerly Stevens Street and ending at the easterly limit of lot 19, Concession C., Township of Widdifield.

PARCEL C -That portion of High Street from Olive Street to the Easterly termination thereof.

PARCEL D -That portion of Rose Avenue from Olive Street to the Easterly termination thereof.

PARCEL E -That portion of Lorne Avenue from Olive Street to the Easterly termination thereof.

DATED at North Bay this 1st day of November , 1926.

LAND TITLES ACT

The Municipal Corporation of the City of North Bay being entitled, for its own benefit, to an interest in the lands known as part of streets in the City of North Bay, in the District of Nipissing, described as follows:-

That portion of Shaw Street beginning at the Northerly boundary of Trout Lake Road and ending at the northerly limit of the City of North Bay.

That portion of High St. formerly Stevens Street beginning at the intersection between Shaw St. and High St. formerly Stevens Street and ending at the Easterly limit of lot 19, Concession C., Township of Widdifield.

That portion of High Street from Olive Street to the Easterly termination thereof.

That portion of Rose Avenue from Olive Street to the Easterly termination thereof.

That portion of Lorne Avenue from Olive Street to the Easterly termination thereof.

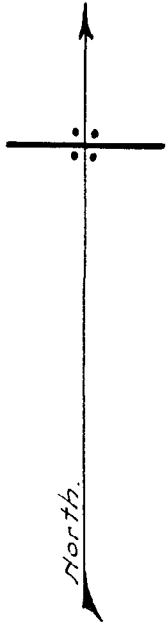
