Being a By-law appointing the persons hereinafter listed to the respective offices or positions hereinafter set forth for the purposes of The Corporation of the City of North Bay.

THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That, for the purposes of The Corporation of the City of North Bay, the following persons be appointed to the respective offices or positions hereinafter set forth:

2. That the aforesaid appointments shall be in accordance with and subject to such Terms of Reference which have heretofore been established or which may hereafter be established relating to the respective offices or positions aforesaid.

5. All previous By-laws or sections thereof inconsistent with the terms and provisions of this By-law shall be deemed to be and they are hereby repealed.
